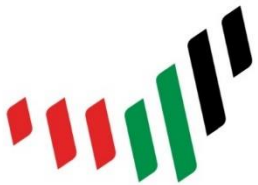

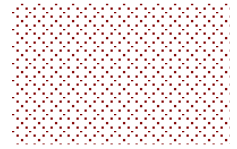

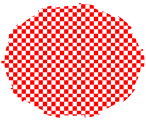
Our Mission

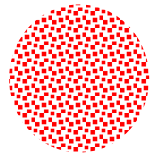
◆ Value Added Tax (VAT)

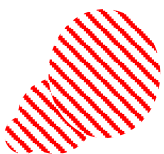

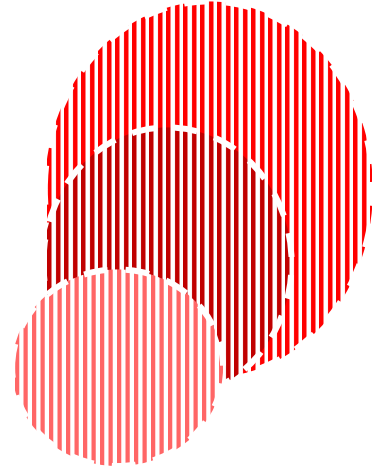
